Nara Lokesh meets various companies representatives, seeks investments to AP

Dovas: During his visit to the World Economic Forum in Davos, Andhra Pradesh Minister Nara Lokesh engaged in productive discussions with Ravi Lamba, the Head of Temasek Holdings India, to attract significant investments in the state's industrial and technological sectors.

Lokesh urged for investments from SembCorp India aimed at strengthening power transmission. improving grid stability, and securing backup solutions to ensure sustainability. Ravi Lamba responded positively, revealing plans to double CapitaLand's investments in the Indian real estate market by 2028. Lamba assured Minister Lokesh that he would consult with his colleagues regarding the Andhra Pradesh government's proposals and make decisions accordingly.

Narayana highlighted that the funds would provide a much-needed boost to various projects, including the construction of the Secretariat, Assembly, and High Court. Negotiations for this loan began last October when Minister Narayana met HUDCO CMD Sanjay Kulshreshtha to discuss the financial requirements
