

# Why is CM not concerned about Maratha children: Jarange

Jarange, who has undertaken several hunger strikes demanding quota in education and government jobs for the Maratha community, was referring to Fadnavis's statement on Tuesday that he had postponed shifting to the



Chief minister's official residence in Mumbai until his daughter's Class 10 exams get over. Speaking to the media, Jarange said, "We saw a father's love for his daughter yesterday...if he has

so much concern for his daughter, why doesn't he care for the children from the Maratha community?" "For your daughter's sake, you are not shifting to another bungalow just 500 metres away...then why can't you see the plight of our kids who hang themselves if they get less marks in exams? Why doesn't the CM give them the reservation which is their right," Jarange added.

# NCP(SP) Eknath Khadse meets Chief Minister Devendra Fadnavis

Nationalist Congress Party (SP) leader Eknath Khadse met Maharashtra Chief Minister Devendra Fadnavis at the latter's residence here, a source said on Wednesday. The meeting took place at 'Sagar', Fadnavis's current official bungalow in south Mumbai, on Tuesday night. The source close to the chief minister. "Khadse met the CM for some personal work. It was not a political meeting," he added, without disclosing what transpired during



the meeting. Khadse, who was with the Bharatiya Janata Party for nearly four decades, stepped down from the Fadnavis-led Maharashtra cabinet in 2016 over a controversial land purchase by his family. Later, he quit the BJP and joined the Sharad Pawar-led Nationalist Congress Party. Before the Lok Sabha elections last year, Khadse tried to return to the BJP's fold, but it did not materialise.

found hanging in his room after family members broke down his door when he didn't respond to them. A suicide note citing financial problems was recovered, and police are investigating. The investigation is complicated by the fact that his mobile phone data had been completely erased. Dehu Road police, led by Senior Inspector Vikram Bansode, are conducting a detailed investigation.

# Over 2,000 IndiGo airline employees join BJP
