## K'taka govt has failed to regulate microfinance institutions: BJP

Hubballi, Jan 23 (IANS): Former chief minister and BJP MP Basavaraj Bommai has accused the Congressled state government of losing control over microfinance institutions (MFIs), leading to widespread harassment of vulnerable citizens. Addressing the media here on Thursday, Bommai alleged that microfinance agencies were resorting to extreme measures, including forcibly seizing even mangalsutras from women. This exploitation, he claimed, has driven families to abandon their homes, with some even taking their own lives.

### **Kasargod rail operations** at risk amid Karnataka power outage

Kasargod, Jan 23: Rail services in Kasargod face a potential crisis due to the suspension of power supply from Karnataka. The issue arose after a transformer at the Udupi Generating Station broke down on January 7, disrupting power to the Uppala Railway Substation.Currently, the railway system relies on electricity supplied from the Jokatte Substation in Karnataka. However, if this supply fails, trains may halt on the tracks, creating significant challenges. operational

Locomotive pilots have reported that voltage drops after trains pass Kasargod, with power to Bekal to Mangaluru operations also dependent on the Jokatte Substation. The affected areas include key facilities such as Mangaluru Central, Mangaluru Junction, and other associated yards. Freight trains further strain the power supply. In some cases, officials preemptively cut the power to prevent overloading, leading to the possibility of trains coming to a standstill on the tracks.

## **Evidence of Ancient Human Activities Discovered in Lava Tube Caves**



ecent advancements in interdisciplinary archaeological research in Arabia have revealed new insights on the development and historical progression of regional human populations. This research has also shed light on the shifting patterns of cultural change, migration, and adaptation to environmental variations. Despite the challenges posed by the limited preservation of archaeological assemblages and organic remains in arid environments, these discoveries are reshaping our understanding of the region's rich cultural heritage. One such breakthrough led Griffith University's Australian Research Centre for Human Evolution (ARCHE), in collaboration with international partners, comes from the exploration of underground settings, including caves and lava tubes, which have remained largely

Through meticulous excavation and analysis, researchers have uncovered a wealth of evidence at Umm Jirsan, spanning from the Neolithic to the Chalcolithic/Bronze Age periods (~10,000-3,500 years ago). ing repeated phases of human occupation and shedding light on the pastoralist activities that once thrived in this landscape," said Dr Mathew Stewart, the lead researcher and a Research Fellow at ARCHE. "This site likely served as a crucial waypoint along pastoral routes, linking kev oases and facilitating cultural exchange and trade."Rock art and faunal records attest to the pastoralist use of the lava tube and surrounding areas, painting a vivid picture of ancient lifeways. Depictions of cattle, sheep, goat, and dogs corroborate the prehistoric livestock practices and herd composition of the region. Isotopic analysis of animal remains indicates that livestock primarily grazed on wild grasses and shrubs, while humans maintained a diet rich in protein, with a notable increase in the consumption of C3 plants over time, suggesting the emergence of oasis agriculture. "While underground localities are globally significant in archaeology and Quaternary science, our research represents the first comprehensive study of its kind in Saudi Arabia," added Professor Michael Petraglia, Director of ARCHE. "These findings underscore the immense potential for interdisciplinary investigations in caves and lava tubes, offering a unique window into Arabia's ancient past.'

# Toxic Rides: New Study Reveals Hidden Dangers in Your Car's Air



A study reveals that personal vehicle interiors are contaminated with cancer-linked flame retardants due to outdated flammability standards. These chemicals, found in 99% of tested cars, pose significant health risks, especially in warm conditions which increase their concentration. The air inside all personal vehicles is polluted with harmful flame retardants-including those known or suspected to cause cancer-according to a new peer-reviewed study published today (May 7) in Environmental Science & Technology. Car manufacturers add these chemicals to seat foam and other materials to meet an outdated federal flammability standard with no proven firesafety benefit."Our research found that interior materials release harmful chemicals into the cabin air of our cars," said lead author Rebecca Hoehn, a scientist at Duke University. "Considering the average driver spends about an hour in the car every day, this is a significant public health issue. It's particularly concerning for drivers with longer commutes as well as child passengers, who breathe more air pound for pound than adults."

The researchers detected flame retardants inside the cabins of 101 cars (model year 2015 or newer) from across the U.S. 99 percent of cars contained tris (1-chloro-isopropyl) phosphate (TCIPP), a flame retardant under investigation by the U.S. National Toxicology Program as a potential carcinogen. Most cars had additional organophosphate ester flame retardants present, including tris (1,3-dichloro-2-propyl) phosphate (TDCIPP) and tris (2-chloroethyl) phosphate (TCEP), two California Proposition 65 carcinogens. These and other flame retardants are also linked to neurological and reproductive harms. About half of the cars were tested in both

summer and winter. Warmer weather was linked to higher flame retardant concentrations because off-gassing from interior components like seat foam is increased by higher temperatures. And vehicle interiors can reach up to 150 degrees Fahrenheit. The

samples of seat foam from 51 of the cars in the study. Vehicles that contained the suspected carcinogen TCIPP in their foam tended to have higher concentrations of TCIPP in their air, confirming foam as a source of this flame retardant in cabin air. Flame retardants are added to seat foam to meet the U.S. National Highway Traffic Safety Administration (NHTSA) Federal Motor Vehicle Safety Standard (FMVSS) 302, an open-flame flammability standard that was first introduced in the 1970s and remains unchanged. "Firefighters are concerned that flame retardants contribute to their very high cancer rates," said Patrick Morrison, who oversees Health and Safety for 350,000 U.S. and Canadian firefighters at the International Association of

Speaking to the media during his visit to Udupi, he emphasized the need to uphold the law and protect the rights of individuals to conduct their business without interference.

"The purpose behind the attack on the unisex salon is not yet known. However, I have instructed the authorities to take action strictly as per the law. Such incidents must not be allowed to occur. Everyone has the right to work, and no one should take the law into their own hands," said Dr

Parameshwar.

The minister assured that the attackers would be identified and dealt with sternly. "If there is any illegal activity happening in these establishments, it should be reported to the authorities. Vigilante actions are unacceptable," Parameshwar added.

Dr Parameshwar also pointed out that trade licenses are issued by the local corporation, and establishments must adhere to the conditions laid out. "If rules are violated, action will be taken. I have instructed the police department to ensure that the attackers are arrested immediately and such incidents are prevented in the future," he stated.
