### India to wear grand necklace of Industrial Smart Cities on backbone of Golden Quadrilateral



NEW DELHI: India will soon wear a grand necklace of Industrial Smart Cities as in a landmark decision on Wednesday, the Cabinet Committee on Economic Affairs chaired by the Prime Minister Narendra Modi has approved 12 new project proposals under the National Industrial Corridor Development Programme (NICDP) with an estimated investment of Rs. 28,602

This move is set to transform the industrial landscape of the country, creating a robust network of industrial nodes and cities that will significantly boost economic growth and global competi-

Spanning across 10 states and strategically planned along six major corridors, these projects represent a significant leap forward in India's quest to enhance its manufacturing capabilities and economic growth. These industrial areas will be located in Khurpia in Uttrakhand, Rajpura-Patiala in Punjab, Dighi in, Maharashtra, Palakkad in Kerela, Agra and Prayagraj in UP, Gaya in Bihar, Zaheerabad in Telangana, Orvakal and in Andhra Pradesh and Jodhpur-Pali in

NICDP is designed to foster a vibrant industrial ecosystem by facilitating investments from both large anchor industries and Micro, Medium Enterprises (MSMEs). These industrial nodes will act as catalysts for achieving USD 2 trillion in exports by 2030, reflecting the government s vision of a self-reliant and

globally competitive India. The new industrial cities will be developed as greenfield smart cities of global standards, built "ahead of demand" on the 'plug-n-play' and 'walk-to-work' concepts. This approach ensures that the cities are equipped with advanced infrastructure that supports sustainable and efficient industrial operations.

Aligned with the PM GatiShakti National Master Plan, the projects will feature multi-modal connectivity infrastructure, ensuring seamless movement of people, goods, and services. The industrial cities are envisioned to be growth centres for transformation of whole

The approval of these projects is a step forward in realizing the vision of 'Viksit Bharat' - a developed India. By positioning India as a strong player in the Global Value Chains (GVC), the NICDP will provide developed land parcels ready for immediate allotment, making it easier for domestic and international investors to set up manufacturing units in India. This aligns with the broader objective of creating an 'Atmanirbhar Bharat' or a self-reliant India, fostering economic growth through enhanced industrial output and employment.

NICDP is expected to generate significant employment opportunities, with an estimated 1 million direct jobs and upto 3 million indirect jobs being created through planned industrialization. This will not only provide livelihood opportunities but also contribute to the socioeconomic upliftment of the regions where these projects are being implemented.

The projects under the NICDP are designed with a focus on sustainability, incorporating ICT-enabled utilities and green technologies to minimize environmental impact. By providing quality, reliable, and sustainable infrastructure, the government aims to create industrial cities that are not just hubs of economic activity but also models of environmental stewardship.

The approval of 12 new industrial nodes under the NICDP marks a significant milestone in India's journey towards becoming a global manufacturing powerhouse. With a strategic focus on integrated development, sustainable infrastructure, and seamless connectivity, these projects are set to redefine Îndia's industrial landscape and drive the nation's economic growth for years to

In addition to these new sanctions, the NICDP has already seen the completion of four projects, with another four currently under implementation. #### RSS chief Mohan Bhagwat's security elevated to ASL level, on par with Amit Shah

NEW DELHI: The Ministry of Home Affairs (MHA) has strengthened RSS chief Mohan Bhagwat's security by upping his existing 'Z+' armed protection to the more robust Advanced Security Liaison (ASL) protocol.

This upgrade involves augmenting the security measures currently provided by Central Industrial Security Force (CISF)

The ASL status brings Bhagwat's security level on par with that of Home Minister Amit Shah.

Officials told ANI that the new directions were issued on

August 16 considering fresh threat analysis report submitted to the MHA by the Intelligence Bureau.

They said that the ASL protocol was previously required only during Bhagwat's visits to certain sensitive locations.

Bhagwat is among 10 persons who have 'Z+' armed security cover by CISF personnel. Currently, a total of 200 protectees are being covered by the CISF personnel.

The security enhancement for the RSS chief comes in response to recent assessments revealing vulnerabilities, especially in states led by non-BJP parties. The report highlights threats from various organizations, including radical Islamist groups, and cites intelligence inputs about Bhagwat's increased risk. This prompted the MHA to classify Bhagwat as an "ASL protectee," necessitating enhanced security meas-

All states and Union Territories have been informed of the security upgrade. Under the ASL protocol, local agencies, including district administrations, police, health departments, and others, are required to collaborate to ensure the protectee's security and safety.

Furthermore, helicopter travel for the protectee is restricted to specially designed aircraft and must comply with detailed protocols. The ASL protocol also mandates thorough anti-sabotage inspections and implements multi-layered security rings to ensure comprehensive protection.

## Union Home, Health Secys chair high-level meet to enhance safety of healthcare professionals

the Supreme Court's August 22 order, Union Home Secretary Govind Mohan and Union Health Secretary Apurva Chandra co-chaired a virtual meeting in Delhi involving the Chief Secretaries and Directors Chief General of Police (DGPs) from various states to implement essential safety measures for doctors and healthcare professionals.

The discussions focused on ensuring that State Governments and Union Territories (UT) take immediate actions to address safety concerns at healthcare workplaces pending receipt of the report of the National Task Force (NTF) to address the concerns of the doctors over their safety at their work-

This follows the National Task Force's (NTF) initial meeting, chaired by the Cabinet Secretary TV Somanathan, which took place on Tuesday.

Atul Goel, Director General of Health Services (DGHS) was present along



with senior officials from the Ministry of Health and Family Welfare in today's meeting. In today's meeting, the

officers of state governments and UTs including Chief Secretaries and DPGs apprised of the steps taken by respective governments to enhance security and provide

a safer working environment for healthcare workers across public and private hospitals, medical colleges and other healthcare institu-

Interacting with the Govind Mohan states, requested the officers to ensure the installation of CCTV cameras in blind spots, integration with 112 helplines for health care workers, access control of large hospitals, and sharing of the revamped position under Bharatiya Nyaya Sanhita (BNS)

Union Health Secretary encouraged the states to

ideas and emphasised some of the immediate measures that can be considered to enhance security and provide a safer working environment for healthcare workers such as joint security audit along with district collector and DSP, and management of District Hospitals (HDHs) and Medical Colleges (MCs) to review any shortfall in existing infrastructure and security arrangements, and to take up remedial measures. Besides, he suggested ensuring security checks of all hired security and other services staff to be done regularly. He stressed the need for a control room, especially in large DHs and MCs, with a duty roster of staff that regularly monitors CCTV and securely stores the data; and that distress call to be attended to by control rooms.

Mock drills for security to be conducted regularly like safety drills for fire, and training of hired security personnel to upgrade their ments, they are observed to be found wanting in discharging their duties due to poor capacities; patient facilitators, trolley men and MTS in large hospitals to ferry patients on wheelchairs and stretchers is required, to reduce the number of patient attendants and lessen the load and stress on security and other healthcare professionals were among other suggestions.

Capacity building and training of doctors and other healthcare workers in bereavement protocols. especially in emergency and casualty wards; security and safety committee to be institutionalized and involve senior or junior residents and students for continuous monitoring of the situation and status of emergency response preparedness; and routine security patrolling in all the hospital and medical college premises during night time were key suggestions of the health secretary.

#### **Pakistani Christian becomes first** in Goa to get citizenship under CAA

PANAJI: A Christian senior citizen from Pakistan, residing in Goa, was given an Indian citizenship certificate by Chief Minister Pramod Sawant on Wednesday through the Citizenship Amendment Act (CAA).

Joseph Francis A. Pereira who currently resides in Cansaulim, South Goa, is the first in the state to get Indian citizenship under CAA.

While speaking to ANI, Joseph thanked Prime Minister Narendra Modi and Home Minister Amit Shah for bringing the CAA. "CAA was applied and within one month, the approval has come. I am very grateful to the CAA that was brought by Prime Minister Narendra Modi and Home Minister Amit Shah." he said.

Joseph Pereira was the only one who had applied for citizenship as his wife was already a citizen of India.

He further said, "I went in 1960 to Pakistan and I did my education there. I got an opportunity to work in Bahrain for 37 years. After my retirement in 2013, I came to Goa and from that time, I have been staying with my family. There are lots of Goan people in Pakistan but I have not visited there. My last visit there was in 1979. I had a hard time there while I was doing schooling as job opportunities were not there." His wife, Martha Pereira told ANI that they were trying to get citizenship from the time they got married, but nothing was helping them. "From the time we got married, have been applying but nothing was coming out of it. We applied through CAA in June this year. Without CAA, there would have been a lot of hurdles," she said. "I am thankful for whatever is happening in our case," she added. Speaking on the occasion, Goa CM Pramod Sawant said that it is a matter of pride for them. "I thank the Prime Minister and the Home Minister. Those who were in Pakistan or elsewhere were asking for citizenship for almost 60 years. So today after the law is passed, we are giving citizenship.

NEW DELHI : The National Investigation Agency (NIA) on opposed Rashid Engineer's bail plea in the Unlawful Activities (Prevention) Act (UAPA) case and stated that if granted bail, Rashid Engineer, as a Member of Parliament, may misuse his position to influence witnesses and obstruct justice.

The agency said a confidential report indicating that Rashid previously misused the telephone facilities in Central Jail, Tihar, leading to restrictions on his call privileges. The NIA fears he might misuse his liberty similarly if released on bail. The NIA claims Rashid defended the 26/11 mastermind Hafiz Saeed's terror activities as a 'political cause,' suggesting a troubling alignment with extremist narratives.

The NIA asserts that Rashid is involved in a strategy by Delhi's Patiala House court.
