

Rajkot drenched in 4 inches of rain..!

Youths and children turned underbridges into swimming pools and splashed; Two CT bus stuck

Rajkot, Rain has arrived in Rajkot today after a long time. 1 inch of rain fell at a slow rate from 4 am to 8 am. After that, the downpour started from 11 o'clock. An average of 4 inches of rain has been recorded by 2 pm. For the first time in the monsoon this time, central, east and west zones of Rajkot have received almost uniform rainfall. As it is still raining, there is a lot of enthusiasm among the people. In the Kalavad Road underbridge, people enjoyed swimming in the rainwater while youth and children everywhere went out to bathe in the rain.

Rajkot has received 4 inches of rain in central zone, west zone and four and a half inches in east zone till 2 pm. Kalavad Road Under Bridge is currently closed due to waterlogging due to heavy rains. While in the low-lying

areas including Papatpara, people are suffering due to flooding of houses and people were seen removing water from their houses. So, as every time at Wagad Chowk, the motorists are in trouble as rain water fills up. Motorists were seen laboriously pulling out their vehicles in the stream of water.

Due to this heavy rain, many low-lying areas of the city are flooded and the motorists are facing a lot of trouble. So the incident of tree falling near Attica also came to light. However, the road was opened after quick action by the fire department.

It has been raining since early morning in Rajkot, forcing the road to be closed due to waterlogging. The city has received an average of 1.5 inches of rain, with 2 inches in the central zone, 2 inches in the east zone and



2.5 inches in the west by 12 noon. Almost all areas of the city are flooded due to heavy rains. While as usual the road has been forced to be closed due to rainwater filling in the Papatpara drain. Although the water disposal system has been started, but due to continuous rains, there is a problem due to high water revenue.

According to the details received in this regard, the areas including Kalavad Road, Race Course, Madhapar Chowk, Mavdi, Kotharia, Ajidam, Gondal Road, Morbi Road and Kuwadwa Road in Rajkot received slow rain in the early morning. Due to this heavy rain, people are facing a lot of trouble as the areas around Aji river and places like Papatpara Nala, Railnagar underbridge are flooded. The underbridge on Kalavad Road was closed due to rain. CNG CT bus stopped here. Apart from this, the areas near Nanamauwa Road were inundated. However, necessary work has been started for the disposal of rain water by the system.

People felt relieved after getting relief from the heat, the main roads of Rajkot like Kalavad Road, Nanamwa

Road, Jamnagar Road, Race Course Ring Road, Gondal Road are also suffering as the water gets flooded. However, with the arrival of rain after a long time, people have got relief from the extreme heat. Many people came out on the road to enjoy this rain. People reached Nahwa in Kalavad Road Bridge. People had come to bathe as if it were a swimming pool.

Farmers have become happy due to heavy rains in the surrounding rural areas including Rajkot. However, the world is also praying that this rain does not become a torrential downpour. If it rains for a longer period of time, there is a possibility of waterlogging in the fields. Now, everyone's meeting is on whether Meghrajia will stop raining Meher Varsi or Kehar Varsaav.

As the Dondi reservoir near Paddhari taluka is getting filled to its full level, one gate of the dam has been opened at 0.61 m to maintain the rule level. Villagers of Pambhar Itala, Nana Itala, Lakshmi Itala and Heidad villages of the dam area will not be allowed to move in the dam area as well as in the bank area, according to the list of the Rajkot District Irrigation East Circle Unit.

Cow smugglers drag cows sitting on the road in a cart near Godhra's Kanelav Ashram

Panchmahal, Another video of cow smugglers near Kanelav Ashram in Godhra city has gone viral. Butchers and cattle smugglers have become rampant in Godhra city. In this viral video, the incident of one of the two cows being taken to the car has been captured on CCTV. There has been a public demand to take legal action against such elements. Incidents of illegal manipulation and trafficking of cattle are happening daily in Panchmahal district as well as in other places. A CCTV footage video is going viral on social media in Godhra city. It is seen that at 12:30 in the night, a Honda City car comes and four of them are seen pushing one of the two cows sitting at the doorstep of the house and pushing it into the car. It is worth mentioning here that this incident of cow poaching also proves.

It is worth mentioning that the accused was wanted for 8 months in the crime of assault, Bhaktinagar police had caught him on the last 14th. While the CCTV footage of the attack in Jain Derasar has also come out today.

Victim lodges complaint in Bhaktinagar police station Mayurbhai Purushottambhai Sagarparya (age 39), resident of Mavdi Astha Residency and owner of a factory named Shiv Hardware in Sorathiawadi, has lodged a

complaint against Bhavesh Vinodbhai Gol in Bhaktinagar police station, stating that on the morning of July 1 last, my elder brother got a call and said that I was going to the factory with an access road when I reached Haridhwa road, we rushed to tell that a driver had hit me and got injured and took the brother to the hospital.

During treatment at the hospital, brother said it was Bhavesh Gol, who after stumbling tried to hit me on the car again after I fell. Even 10 months ago, Amitbhai was beaten with a knife, as the police arrested him after filing a complaint, he was attacked again later when he was visiting the Khar Rakhi temple, so a complaint of attempted murder was registered against him in the division police station.
