ASG Eye Hospital Wearing glasses has become a common problem in children. Especially after the Covid pandemic, many children have started wearing glasses. There are many reasons for any child to wear glasses, the main ones being genetics and our lifestyle. If your mother or father has Myopia or nearsightedness, then their children are also more likely to wear glasses. If children are spending more time on mobile, laptop, iPad, then there is a possibility of the number of glasses increasing even more. Not getting the eye checkup done and getting the glasses number on time increases the risk of having Amblyopia or myopia in the eyes. Due to this the retina of the eyes becomes permanently weak. For the first time a dedicated eye service is being started at ASG Eye Hospital, Jodhpur to diagnose serious problems like nearsightedness and amblyopia together. In this case will be found out by examining the eyes of children in detail. Some eye drops and specially designed glasses are given on the basis of consultation and with some lifestyle changes the number of glasses can be increased or decreased. Amblyopia can also be treated with modern computer patching techniques from five (5) years to sixty (60) years of age. Everyone should get their child's eyes checked every 6 months to prevent any serious problem.

Medipulse Hospital, located in Basni, has installed a new neuro electrophysiology machine in the neurology department, adding to the super specialty medical facilities available here. Dr. Anka Arora, senior neurologist of the hospital, said that the availability of this state-of-the-art facility has expanded the existing clinical electrophysiology services of the hospital. She said that earlier only the facilities of nerve conduction study (NCS) and electroencephalogram (EEG) were available in the hospital, but with the installation of this machine, facilities for tests like electromyography (EMG), visual evoked potential (VEP), brainstem auditory evoked response (BAER), repetitive nerve stimulation test (RNS), SSR (sympathetic skin response) have also become available here. He said that this facility will facilitate accurate treatment of patients suffering from myopathy, myositis, radiculopathy, brachial plexopathy, myasthenia gravis, multiple sclerosis, myelitis and other demyelinating diseases. Dr. Arora said that this medical facility is very effective especially in diseases of nerves and muscles due to which the patient has to face many problems due to not getting the right instructions from the brain. Medical Superintendent of the hospital Dr. Sumita Agarwal said that this is another meaningful step towards the promise made by the institute to provide all types of super specialty medical facilities under one roof to the patients of entire western Rajasthan. She said that this process will continue in future also.
