Ahmedabad Meghraja has created a ruckus in Gujarat for the last one week. The low pressure created in the Bay of Bengal turned into a deep depression after reaching Gujarat. Because of this, a situation of universal heavy rains was created across Gujarat. Although, now Meghraja Khamaiya will occur in North, Central, North-East and South Gujarat districts, but still for 48 hours Saurashtra and Kutch conditions will remain unchanged and heavy to very heavy rains may occur. Rainfall conditions are predicted every three hours by the Meteorological Department. According to the 10 o'clock forecast today, the depression has reached the Arabian Sea through the Gulf of Kutch. Due to this, the districts of Saurashtra and Kutch may experience heavy rains.

Due to which the customers are seeing anger along with concern. On the other hand, according to the bank manager, since yesterday, 3 different motors are being installed to drain the water. Also, if the intensity of rain remains low till this evening, the water will be removed.

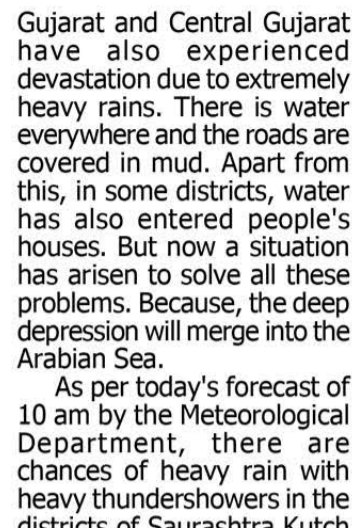

Meghraja has been battling with a bang for the last three days in Gujarat. In the districts of Saurashtra Panthak, the people are now praying that Meghraja Khamaiya will do the heavy rains. It has rained in most of the districts of Saurashtra during the last 24 hours and the people and the system are still worried about the rain.

Big Khilori village of Gondal taluk had an Ikko car washed up in the Kolpari river. Ikko car used to go from Vasavadi village to Big Khilori. Meanwhile, the Ikko car was passing over the sata bridge of the Kolpari river in the village of Bigi Khilori, when the Ikko car got stuck in the water flow due to the sudden increase in the flow of water.

Three members of the family including a child were traveling in the Ikko car. Searching for the missing family, the family was going to their relatives in Gondal's Big Khilori village in the Ikko

car. The Gondal Municipal Fire Team reached the spot and searched for the family. In which Ikko car was found. Three people in the car are missing. Efforts are being made to pull out the Ikko car from the river with the help of other vehicles. Fire team and NDRF have been assisted. Police staff including Dy.SP KG Jhala, Taluka PSI have reached the spot regarding the entire incident.

BJP leaders including Gondal MLA Gitaba Jadeja, Rajkot district BJP president Alpeshbhai Dholriya, Prfulbhai Tolia, Ashwinbhai Thoonmar and Rajubhai Dangar have reached the scene.

Jayeshbhai Parsotambhai Raddia (aged 40), Sonaiben Jayeshbhai Raddia (aged 39) and Dharmesh Jayeshbhai Raddia (aged 11) living in Raipar village of Babra taluka.

These three persons were riding in the Ikko car. The Ikko car has been found, but the search for the missing family is on.

After 7 years, boats ply on Ahmedabad roads

Fire brigade rescues victims by boat from water in Kedsama in Nikol

For two days, Meghraja has left Gujarat state in water. In the city of Ahmedabad also, the eastern area became water-bombed due to Meghraja's stormy battering in two days. After seven years in the Madhumalati Awas Yojana area on the Nikol-Kathwada road, the boat has to be operated once again. In the year 2017, former Chief Minister Vijay Rupani sat in a fire brigade boat due to rain and inspected the Nicol Madhumalati residence which was affected by heavy rains.

Then once again the fire brigade boat was used to rescue the sick young man and the family with four children in the housing scheme. The Madhumalati Housing Scheme area turned into an island due to heavy rains on August 26. For the last two days, outside and inside the houses of Madhumalati Awas Yojana were filled with waist-deep water in an area of 700 one kilometer. Over 1000 people living in the housing scheme were trapped due to waterlogging due to heavy rains. People could not go out of their houses due to inundation of rain water. In Madhumalati Awas Yojana, a youth was forced to be admitted to the hospital due to high fever and illness. Due to which the help of Ahmedabad Fire Brigade was taken.

A team from Nicol Fire Station reached there with a rescue boat. The youth, who was suffering from cold and high fever, was put in a boat and brought out to the road by the fire brigade staff. A family with four children had to move out of their home. So the fire brigade rescue team

brought 6 people including four children out of the houses of the housing scheme. For about five hours, the rescue team of the fire brigade returned to the Nikol Madhumalati Awas Yojana area. It is estimated that more than 1000 people live in the houses of the housing scheme. As people could not move outside due to heavy rain, food packets including water and biscuits were sent to them by the rescue team of fire brigade.

An area of two kilometers was submerged in water and there were many places in the eastern part of the city where people could not move. Due to inundation of rain water, they had to face a lot of hardship. However, as it was a Janmashtami holiday, people did not need to travel on the road much. But the area including Saraspur and Rakhial in the east where one to two kilometers area was submerged in water at many places. Where people used to go even though it was not a walkable situation. But fire brigade boats and machinery were not used in some places.

Unjha Mamlatdar visited the affected

Unjha According to the forecast of the Meteorological Department, the whole division, including Unjha city, has received a fair amount of rain for the last two days. As a result, low-lying areas were flooded at many places. Due to the rain, the motorists lost their lives when an acacia tree fell on the road on Unjha Dasaj Road. However, the trees that fell on the road were removed after being informed to the concerned authorities. Due to the rain in Unjha, the low-lying areas including Umia Mataji Chowk were flooded. Malay area and

Chhapra area on Unjha

Wanagala Road were flooded. On this, Unjha Mamlatdar Rekhaben Rawal reached the spot and visited the people. Also, the water drainage work was removed with the help of the municipal workers. Apart from this, motorists were suffering after an acacia tree fell on Unjha road in Dasaj village of Unjha taluk. However, the cutting of both the trees was done through the forest department and the road was opened. Due to the rainy weather, the weather became cold in the whole district including Unjha city.
